The Executive Director, Dr. Eric Skanson, will provide updates on current programs and key events at STRIDE Academy.

- Continuing to work through the realities of having multiple sites.**
- MDE charter leaders corp met today.**
- MDE Revenue findings: they were taking a look at contracted service providers indicating that the way we work with our SpEd Director is not appropriate saying that they are acting more as an employee. The result is that we have about ten thousand in back taxes that we are going to be paying for over 3 years of working with both Marlene and Cyndi. We are addressing that going forward.**
- Met with our current bondholders regarding some of the items that we need moving forward and brought them up to speed.**
- Submitted our review and comment to the MDE.**
- PUC submitted our affidavit for expansion. Now we are waiting on any next steps or if MDE is going to have an interaction.**
- Update on Transportation, working through some of the financial pieces with the bus company. Math & Science is considering stepping away from our partnership for next year which will impact our overall costing. It means about 30% savings for us.**
- A short week ahead with training in the mornings and finish with some food and get staff together.**
- To celebrate some Stride Excellence: October * Kym Craven *Erica Lewis. November *Rachel Carlson *Rochelle Berger. We are extremely proud of each of them.**
