

CONSULTANT AGREEMENT
SCHOOL PSYCHOLOGY SERVICES
2022-2023

This agreement dated July 1, 2022 is made between STRIDE Academy, 3241 Oakham Lane, St. Cloud, MN and AnneMary Wielkiewicz, 1714 Boxwood Circle, St. Cloud, 56303.

SERVICES: STRIDE Academy hereby employs AnneMary Wielkiewicz to perform the following services in accordance with the terms and conditions set forth in this agreement; AnneMary Wielkiewicz, EdS NCSP, will serve as the School Psychologist for up to 100 days for the 2022-2023 school year.

TERMS OF AGREEMENT: This agreement will begin on July 1, 2022 and will end June 30, 2023. Either party may cancel this agreement on a one week notice to the other party in writing or personal delivery.

TIME DEVOTED BY ANNEMARY WIELKIEWICZ: It is anticipated that AnneMary Wielkiewicz will spend approximately 1 to 2 days per week on campus at STRIDE Academy. In addition to the days on campus, AnneMary Wielkiewicz may work from home when there is work that can be completed at her home office. AnneMary Wielkiewicz may attend Minnesota School Psychologist Association Conference (2 days). There may be requests for other conference days if it will benefit STRIDE Academy.

PAYMENT: AnneMary Wielkiewicz will be paid at the rate of \$70 per hour for work performed in accordance with this agreement. AnneMary Wielkiewicz will submit monthly statements to STRIDE Academy for payment. AnneMary Wielkiewicz will inform the Executive Director and the Principal of her monthly work schedule.

CONFERENCE REGISTRATION: STRIDE Academy will be responsible for the registration costs for workshops/conferences that AnneMary Wielkiewicz chooses to attend.

INDEPENDENT CONTRACTOR: Both STRIDE Academy and AnneMary Wielkiewicz agree that AnneMary Wielkiewicz will act as an independent contractor in the performance of the duties under this contract. Accordingly, AnneMary Wielkiewicz shall be responsible for payment of all taxes including federal, state, and local taxes arising out of activities in accordance with this contract.

CONFIDENTIAL INFORMATION: AnneMary Wielkiewicz agrees that any information received by her during furtherance of her obligations in accordance with this contract, which concerns the personal, financial, or other affairs of STRIDE Academy will be treated by AnneMary Wielkiewicz in full confidence and will not be revealed to any persons, firms, or organizations.
